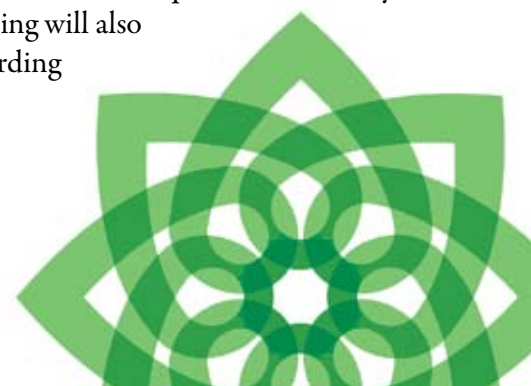
- Emotional/behavioral outbursts or problems with dysregulation
- Difficulty with attachment(s)
- Present with no questions or concerns regarding their adoption/foster care status
- Difficulty with adjustment to out of country placement
- Self harming or risky behaviors
- Anxiety or hypervigilance regarding their biological families
- Multiple diagnoses, including; Reactive Attachment Disorder, Oppositional Defiance Disorder, Disruptive Behavior Disorder, ADHD, and Conduct Disorder

Are you working with adult adoptees or adults with a history of foster care placement who exhibit any of the following symptoms?

- Difficulty forming close emotional relationships

- Self harming or risky behaviors
- Difficulty with communicating needs appropriately
- Demonstrating rigid or perfectionist characteristics
- Multiple diagnoses from many providers

In this seminar, we provide training on the 7 core issues in adoption and on the hidden losses/trauma experienced by individuals impacted by foster care and/or adoption. Participants will learn how to apply this knowledge in interacting with adoptive/foster families for maximum engagement, to facilitate genuine relationships within the adoptive/foster family and build resiliency in the adopted/foster child at all stages of development. This training will also examine the common myths associated with adoption/foster care, societal stigma regarding adoption/foster care, and strategies to help the adoptive/foster family to navigate these issues with fuller understanding of the emotional needs of their child.

Who should attend? Social workers, psychologists, family therapists, psychiatrists, school counselors, educators, child life specialists, case workers, mental health counselors, graduate students, any professional working with persons or families touched by adoption/foster care.



LEARNING OBJECTIVES

- Integrate a trauma informed approach to understanding adoptive/foster families
